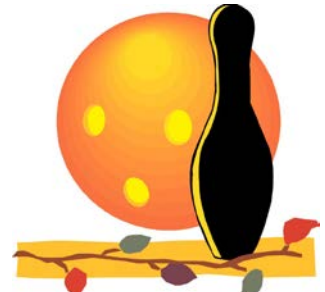

DOUBLES / Div A & B
HANDICAP: 90% of 450

1. Tournament shall be governed by USBC Rules
2. Entrants must be a USBC certified bowler and one of the following:
 - a. A current member of the Morris County Women's 600 Club
 - b. A qualified Guest member who is a member in good standing of any NJ Women's 600 Club
 - c. A qualified Guest member bowling with a current 600 Club Member
 - d. There is a fee of **\$5.00 for non-Morris County Women's 600 Club members**
3. Three (3) games in each event will be bowled on the same pair of lanes.
4. Entering averages will be determined in the following order
 - a. Highest Morris County book average for the 2010-2011 winter season, minimum of 21 games
 - b. Highest Morris County book average for the 2011 summer season, minimum of 21 games
 - c. Highest Morris County average as of October 31, 2011, minimum of 15 games
 - d. Other association highest 2010 - 2011 season average
 - e. Entrants not meeting the above requirements shall bowl scratch with an average of 225

Verification required with entry options c & d

Error in submitted averages will be penalized in accordance with USBC Rule 319a-3. Ten pin rule does not apply
5. The Tournament Director will verify all averages UPON RECEIPT of completed entry form.
6. The decision of the Tournament Executive Board will be final, unless an appeal is made in accordance with the USBC Rule 329.
7. Per USBC Rule 319d, bowlers need not report previous tournament prize winnings as this rule is waived.
8. USBC Rule 319e is waived.
9. Two (2) divisions in the singles event

176 & higher average	DIVISION A
175 & lower	DIVISION B

Two (2) divisions in the doubles event	
352 & over	
up to 351	
10. Doubles event will be 3 games of 9 Pin No Tap format.
11. Entrants may bowl a) singles only or b) singles and doubles.
12. If a bowler wins \$600.00 or more in tournament(s) within a calendar year (January 1st to December 31st) they must be issued a 1099 miscellaneous tax form. In order for our club to comply, the bowler must submit their social security number when requested.
13. All returned check fees charged to Morris County Women's 600 Club plus a \$25.00 redeposit fee will be the responsibility of the person whose name appears on the check.

"Prize list" will pay 1 place for every 5 entries – Prize money returned 100%
